TO THE CITY OF LAKEWOOD, CALIFORNIA:

The undersigned, and each of them, do hereby certify that they are registered owners of the following vehicle:

The undersigned volunteer to participate in Operation L.A.W. (Lakewood Auto Watch), an auto decal registration program with the City of Lakewood operated by the Los Angeles County Sheriff's Department, the law enforcement agency of the City of Lakewood at the Lakewood Sheriff's Station, 5130 N. Clark Avenue, Lakewood, California 90712. Each of the undersigned does hereby as his or her individual act certify the following:

I have received Decal No. _____ from the Lakewood Crime Prevention Unit which will be placed on the left side of the rear window of the above described vehicle.

By participating in this program I certify to the City of Lakewood, a Municipal Corporation, the County of Los Angeles, a Body Politic, of the State of California, and the Los Angeles County Sheriff and personnel, that my vehicle will **NOT BE OPERATED WITH MY PERMISSION BETWEEN THE HOURS OF 1:00 A.M. AND 5:00 A.M.**

I understand that the presence of this decal, affixed to the window of my vehicle at the place indicated by the Sheriff, indicates to any law enforcement agency that this vehicle is being operated without my permission between the hours of 1:00 and 5:00 A.M. If any law enforcement agency observes a person operating my vehicle during those hours, I hereby consent to any investigative stop, retention of said vehicle, the detention of any person therein or the arrest of any person therein including the undersigned.

I fully understand that by registering with this program and maintaining said decal on my vehicle that myself or any other person operating my vehicle between the hours of 1:00 and 5:00 A.M., with my consent, are subject to police stop based on this consent. In such instances, I understand that police action will include the necessary precautions generally taken to protect officers when approaching a potentially stolen vehicle. I agree to specifically advise any person that I give possession of my vehicle that this agreement exists and they shall not operate the vehicle between 1:00 and 5:00 A.M. and that if they do they will be subject to being stopped by the police, detained, and/or arrested during those hours. By my participating in this program, and because of the possibility of my arrest or the arrest of any person using or occupying the vehicle with my consent between the hours of 1:00 and 5:00 A.M., or the possibility of possible harm to myself or any person occupying said vehicle because of necessary police action taken in such a case, **I HEREBY AGREE THAT I WILL NOT AUTHORIZE ANY PERSON WHO HAS MY CONSENT TO OPERATE MY VEHICLE TO LET ANYONE ELSE USE THE VEHICLE OTHER THAN THAT PERSON TO WHOM I HAVE GIVEN CONSENT TO POSSESS AND/OR OPERATE SAID VEHICLE.**

I fully understand that the only way I may remove myself from this program and the threat of being arrested or detained or my vehicle being detained is to fully remove the decal from my vehicle. I further agree that I will immediately upon removal of the decal from my vehicle proceed to the Sheriff's Department and execute the termination clause attached to this Registration Form.

I further do agree to remove the decal prior to its sale or transfer to any person not signing this agreement as a registered owner and to terminate the registration as hereinbefore provided.

I hereby consent and agree to abide by the above procedures. I also hereby give my consent to any peace officer to stop my vehicle between the hours of 1:00 A.M. and 5:00 A.M. whether operated by me or anyone else as long as said decal remains thereon and I have not terminated my registration in this program. I further agree that I will advise anyone I allow to use or occupy my vehicle of these conditions and they are not to operate my vehicle or be in my vehicle between the hours of 1:00 A.M. and 5:00 A.M. I further understand that registration in this program is applicable to my vehicle, and any person therein, between the hours of 1:00 A.M. and 5:00 A.M. whether the vehicle is in operation, stopped or parked unless on or near the address set forth below.

FOR AND IN CONSIDERATION of being allowed to participate in OPERATION L.A.W. of the Los Angeles County Sheriff's Department and the City of Lakewood, the undersigned, and each of them, do hereby release, acquit and forever discharge the CITY OF LAKEWOOD, a Municipal Corporation, and all officers and employees thereof, THE COUNTY OF LOS ANGELES and the LOS ANGELES COUNTY SHERIFF'S and all officers and employees thereof, for any and all claims, demands, damages, actions, causes of actions, or suits of any kind, including, but not limited to, claims for injury or death or damage to my person or property which may arise as a consequence, or arise out of the acts of the foregoing in performing OPERATION L.A.W.

The undersigned further agrees to defend and hold harmless the County of Los Angeles, the Los Angeles County Sheriff, the City of Lakewood, its officers and employees from any liability, claims, suit, damages or judgment for injury to person or property including false arrests and imprisonment, assault and battery or wrongful death arising out of the performance of this program, except where such injury, damage or loss arises by reason of the misfeasance or nonfeasance of the County of Los Angeles, the Los Angeles County Sheriff, or the City of Lakewood or its officers and employees.

The undersigned, and each of them, by the execution of this form, acknowledge he/she has read, understands and agrees to voluntarily accept the provisions hereinbefore set forth and that each of them know the contents hereof and sign the same as his or her own free act. The undersigned and each of them further acknowledge that this registration form and release contains the entire agreement and understanding of the undersigned and the aforementioned public entities and officers and that there is no other agreement or understanding.

The undersigned and each of them do hereby certify that he/she or they are the sole owners of the following described vehicle and that they are so registered with the State of California, Department of Motor Vehicles. Each of the undersigned agree that they will immediately notify the Sheriff's Department of any change of address or phone numbers hereinafter set forth.
