



Lakewood Home Security Camera & Alarm System Rebate Program

Program Information

The City of Lakewood is offering residents the opportunity to receive rebates related to home burglary prevention measures. The rebate program is offered on a first come, first served basis, to Lakewood residents who purchase and install exterior, hard-wired, security cameras and/or installation and activate a new residential security alarm system on or after July 1, 2024. All rebate opportunities are open to all city residents. Rebates are available until program funding is expended – apply early for best opportunity at receiving a rebate.

Available Rebates

Lakewood residents may be eligible to receive one of each type of following rebates:

1. Security Camera Rebates
 - i. \$75 rebate for purchasing and installing one security camera
 - ii. \$150 rebate for purchasing and installing two security camera
2. Security Camera Installation Rebates
 - i. \$75 for installation of at least one security camera via hard-wire electrical connection, by a third party, for an installation cost of \$150.00 or greater
 - ii. \$150 for installation of at least one security camera via hard-wire electrical connection, by a third party, for an installation cost of \$300.00 or greater
3. New Home Security Alarm System Rebate
 - i. 50% for installation and activation cost for a new alarm system, up to \$200.00

Program Eligibility

Each applicant must meet the following requirements:

1. Reside in the City of Lakewood and have a valid government issued ID displaying your City of Lakewood residential address.
2. Have a current utility bill (water, electricity, gas, phone) registered in your name to your City of Lakewood residential address, matching the Lakewood address on your valid government issued ID. Your utility bill must be dated no more than 60 days before the date you submit your application.
3. Own or rent the City of Lakewood residence where the security camera(s) or alarm system will be installed. If currently renting, a signed letter from the owner of the Lakewood residential property is required expressly giving written consent to you to install the security camera(s) or alarm system on the residential property.

Security Camera Rebate Requirements

To be eligible for a security camera rebate, each security camera must meet the following requirements on or after July 1, 2024:

- Be a brand-new, in original packaging, non-refurbished, security camera. Cameras must be hard-wired or solar powered; battery operated cameras are ineligible.
- Each security camera must have a total sale price, before taxes and installation, of \$100.00 or greater
- Be installed in order to capture any of the below listed camera angle(s):

Residential Front Door	Residential Front Driveway	Backyard Fence Line
Front/Side Facing Sidewalk	Residential Front Yard	Garage Door Entrances
Adjacent Alley Way	Side Yard	

Security Camera Rebates

- **\$75.00** for minimum of (1) security camera purchased for total sale price of \$100 or greater before taxes and installed capturing one of the eligible camera angles
- **\$150** for minimum of (2) security camera purchased for total sale price of \$200 or greater, before taxes and installed capturing two of the eligible camera angles

The rebate is exclusively for the cost of the security camera(s) not including any applicable tax. The rebate does not include the cost for security camera installation, additional storage space, accessories, or any cameras that are purchased, but not installed.

Security Camera Installation Rebate Requirements

To be eligible for the security camera installation rebate, the following requirements must be met on or after July 1, 2024:

- Installation of each security camera must be performed by a third-party service provider at cost to the home owner where the security camera(s) were installed
- Installation of each security camera must be via hard wire electrical connection to the exterior of the home (battery operated security cameras are ineligible)
- Eligible camera angles include:

Residential Front Door	Residential Front Driveway	Backyard Fence Line
Front/Side Facing Sidewalk	Residential Front Yard	Garage Door Entrances
Adjacent Ally Way	Side Yard

Security Camera Installation Rebates

- **\$75.00** for minimum of one security camera installed capturing eligible camera angle. Security camera installation cost of \$150.00 or greater.
- **\$150** for minimum of two security cameras installed capturing two eligible camera angles. Security camera installation cost of \$300.00 or greater.

New Home Security Alarm System Rebate Requirements

To be eligible for the new home security alarm system rebate, the following requirements must be met on or after July 1, 2024:

- Installation and activation of a new home security alarm system.
- Residential security alarm system service must include ongoing monthly monitoring service for a minimum of 1 year.
- Residential security alarm system service must include new installation and activation of the following new equipment:
 - Minimum of (1) interior control panel, with audible alarm/siren
 - Minimum of (2) door sensors installed on exterior facing doors
 - Additional system equipment installation, in addition to the above mentioned, is eligible
 - Ex: cameras, window sensors, additional door sensors, etc.

New Home Security Alarm System Rebates

- **50%** of installation and activation costs for a new alarm system, before taxes, up to a maximum \$200 rebate. Monthly monitoring service costs not eligible for rebate.

Application Requirements

Application Documents

1. Complete the Lakewood Home Security Camera & Alarm System Rebate Application on the next page.
2. Include the following required documents as attachments:
 - a. Completed home security camera & alarm system rebate application
 - b. Copy of sales receipt dated July 1, 2024 or later
 - c. Copy of valid government issued ID with City of Lakewood residential address
 - d. Copy of current utility bill (water, electricity, gas, phone) registered in your name to your City of Lakewood residential address, matching the Lakewood address on your valid government issued ID. Your utility bill must be dated no more than 60 days before the date you submit your application
 - e. If renting – copy of letter from property owner allowing installation of security camera(s) or alarm system.
 - f. Photo of each security camera installed to exterior of your home
 - g. Image from each security camera feed displaying camera angle
 - h. If applying for the home security alarm system rebate, include items a-e, plus the following:
 - i. copy of signed contract showing start of service on or after July 1, 2024, for a minimum 1 year of monitoring services
 - ii. copy of sales invoice listing installed equipment and total cost for equipment and installation
 - iii. photos of installed (2) door sensors and master control panel
